- 8:20 a.m. Clerk Leffel reported the following:
  - She would like to attend a seminar concerning Davis-Bacon rules. The Board verbally approved the request.
  - Safe at Home Initiative speaker for the next elected officials meeting.
  - Steve Potoczak sent the bid tabulation sheets for the airport obstruction project.
  - She reviewed the office calendar for the next several weeks.
- 8:30 a.m. County Administrator Preston reported the following:
  - Updated the Board on the need to retain the ten dollar fee for the Municipal Court.
  - The IT department will be changing the view on the video monitors at Municipal Court West.
  - Spoke to the CCAO about the Budget Commission adjusting collection of levy dollars.
  - She will be working with Prosecutor Ed Pierce to clarify some contract language for the proposed opioid litigation engagement letter.

Specifically, the Board discussed the application of ORC Section 3721.042.

- 10:00 a.m. The Board met with Wapakoneta Safety Service Director Chad Scott to discuss the Wapakoneta storm sewer assessment collection in the incorporated portion of the city and how it might be utilized to pay for individual parcel assessments for drainage that flows from the incorporated portion of the city to the unincorporated area of the proposed drainage project. The Board will check and see what the county has been paying in storm sewer assessments for the proposed area. Mr. Scott asked if the County would inspect the tile from the south edge of the field to the south side of Infirmary Rd. The Board will request assistance from the Engineer's office. Mr. Scott asked for permission to access the field north of the County Home to inspect an outlet for a retention pond for a housing subdivision east of the Acres.
- 1:30 p.m. The Board met at the Airport with Airport Manager Ted Bergstrom for the monthly update. The Board viewed the construction work currently being done. Ted outlined some of the items to be addressed as the construction progresses. These include items such as signage and relocation of temporary utilities.
