WHEREAS, Lessor and Lessee are parties to a certain Ramp Tie-Down Space entered into on September 29, 2020, as evidenced in Resolution 20-379 for the right to the use of an main apron parking space at the Auglaize County Neil Armstrong Airport, for the purpose of storage of Leariet N128LR, ("the Agreement); and

WHEREAS, Lessee and the Auglaize County Airport Authority (the "Authority"), have recommended that this Amendment be executed to reflect current terms and adjustment to the monthly lease amounts.

**NOW, THEREFORE**, in consideration of the mutual promises and covenants herein contained and other good and valuable consideration, the receipt, sufficiently and adequacy of which are hereby acknowledged, the parties hereto agree as follows:
