The Board of County Commissioners convened in regular session at 8:00 a.m. on Tuesday, March 17, 2026 in the Commissioners' Chambers with the following members present: David Bambauer, Douglas A. Spencer, and John Bergman. The meeting of the Board was called to order by President Bergman.

- 8:00 a.m. Commissioner Bambauer moved to approve the resolutions as presented.
Commissioner Spencer seconded the motion. The resolutions were then distributed for each Commissioner's vote and execution.
- 8:51 a.m. Clerk Donovan read the minutes of the March 12, 2026 meeting.
 - The minutes were approved with some clarification.
 - BOCC calendar was reviewed.
- 9:05 a.m. County Administrator Preston presented the following:
 - Reported the Engineer's office is obtaining agreements for mowing of sewer plants for 2026.
 - Discussed the job description for an open IT position, as well as an audit needed to a current role within the department.
 - Discussed the wind damage to the courthouse roof, vehicles at the courthouse parking lot, and damages to the dog warden building and vehicle on Friday, March 13, 2026. Reported the insurance claims have been made. The commissioners have also requested a review of the existing roof area at the courthouse by the maintenance department for any additional claims.
 - Discussed the airport masterplan extension request. The commissioners asked Administrator Preston to schedule an in-person meeting with the FAA to go over details within the request.
 - Discussed a request from the Sheriff to increase limits on two credit cards used within their office. The Board is open to this request.
 - Reported action is needed on opioid litigation. The commissioners authorized the County Administrator to sign the additional 6 entity agreement provided by council.
 - Reported the .gov grant has been submitted.
