- 2. It is agreed by both County Boards that there will not be a per diem rate charged for holding each other's prisoners; however, each county will be responsible for their own inmate's medical costs.
- 3. Housing may be declined based on the inmate's mental and/or medical condition and whether they pose a serious safety and/or security risk.
- 4. The Sheriff's will decide on housing for any unforeseen circumstances such as short term overcrowding, building repair/maintenance, and or remodel.
- 5. Either Sheriff may be contacted for a final housing decision.
- 6. This agreement may be terminated by either party by 30 days written notice to the other party.
