The Board of County Commissioners of Auglaize County met in regular session on the 24th day of March, 2026.

Commissioner David Bambauer made the motion to adopt the following:

**RESOLUTION**

**WHEREAS**, the Board of Commissioners has received a PY2025 Community Development Block Grant (CDBG) Allocation Program. Project Activities: #2-1. Street Improvements: City of St. Marys Scott Street Improvements. CDBG Allocation Funds: \$80,000. Project involves resurfacing approximately 1,351LF of Scott Street, from Spring Street to Oil Street; along with related appurtenances: replacement of approximately 211LF of related curb and approximately 285LF of related sidewalk for ADA curb ramps to street level. Single-Year Project. City of St. Marys, Auglaize County, OH. Estimated cost of project activity: \$118,112+/- (\$80,000 CDBG and \$38,112 City General Funds). #3-1. Public Rehabilitation: Minster FJ Stallo Public Library ADA Elevator. CDBG Allocation Funds: \$67,200. Project involves installation of an ADA-compliant elevator in an existing old freight elevator shaft and related appurtenances. Single-Year Project. Village of Minster, Auglaize County, OH. Estimated cost of project activity: \$289,455 (\$67,200 CDBG and \$222,255 Village of Minster Capital Improvement Funds).

**WHEREAS**, the Environmental Review Record (ERR) has been completed for each of the projects listed above; and,  
**WHEREAS**, the required public notice of the notice of intent to request a release of funds sets forth a period of time expiring on April 2, 2026 at 4:30 p.m. during which time written comments regarding the finding will be received by the Commissioners' Office for consideration.

**THEREFORE, BE IT RESOLVED** that the Board of Commissioners, Auglaize County, Ohio hereby authorizes and directs the Clerk of the Board to post the herein described Public Notice and formally authorizes the publication of the same in The Evening Leader and The Wapakoneta Daily News on March 26, 2026; and,

**BE IT FURTHER RESOLVED** that the Board hereby authorizes the Board President to sign any and all documents required by the State of Ohio related to the Environmental Review of the PY2025 Community Development Block Grant (CDBG) Allocation Program and the Request for Release of Funds on behalf of the Board of County Commissioners.
