The Board of County Commissioners convened in regular session at 8:00 a.m. on Tuesday, March 6, 2018 in the Commissioners' Chambers with the following members present: Douglas A. Spencer, Don Regula and John N. Bergman. The meeting of the Board was called to order by President Spencer.

- 8:20 a.m. Clerk Leffel read the minutes of the March 1st, 2018 meeting. The minutes were approved with some clarification.

8:25 a.m. Clerk Leffel reported the following:

- Clerk reviewed the PI Fund and BOCC funds with the February expenses expended from those funds.

- 9:00 a.m. Commissioner Bergman moved to approve the resolutions. Commissioner Regula seconded the motion. The resolutions were then distributed for each Commissioner's vote and execution.
- 9:05 a.m. The Commissioners received and signed the check register as presented by the County Auditor's Office.
- 9:15 a.m. Clerk Leffel read the minutes of the March 5<sup>th</sup> & 6<sup>th</sup>, 2018 meetings. The minutes were approved with some clarification.
- 9:20 a.m. Clerk Leffel reported the following:
  - Received a call from a resident about Freyburg property lines.
  - Reported on the change of online auction services from LightGov to GovDeals.
- 9:30 a.m. County Administrator Preston reported the following:
  - We have received a resignation letter from an employee at the Recycle Center.
  - Spoke with Paul Lang and Peyton Stanforth about the sale of Auglaize Acres for the continuance of operations. The Board authorized the Administrator to set up a call with outside counsel and the state regarding bed licenses laws.
  - She reported on the costs of the drainage & utility project at the Airport.
  - Reported that the goal for TeleDoc has been achieved. The Board advised that they still
    wanted to move forward with the incentive program for Teledoc registration.
  - She reported on opioid litigation details from the two firms who made a presentation last Tuesday.
  - She reported that First English Lutheran Church requested permission to use the parking area east of the Extension Office on May 5<sup>th</sup>. The Board granted such usage.
- 9:44 a.m. Commissioner Bergman moved to go into executive session to discuss the possible purchase of real estate and invited the County Administrator to attend. Commissioner Regula seconded the motion. Chairman Spencer called the roll: Bergman-yes; Regula-yes and Spencer-yes.

- 10:00 a.m. The Board met with St. Marys Mayor Patrick McGowan, St. Marys Attorney Kraig Noble, St. Marys Attorney Zach Ferrall, Engineer Craig Moeller, Community Development Director Mike Burkholder, Noble Township Trustees Brian Cook, Greg Leffel and Grant Shaner Midwest Electric Manager Matt Berry and Solid Waste Coordinator Scott Cisco.

The topic of discussion was the purchase of real estate for expansion of the Recycle Center and the requirement of annexation to the City of St. Marys.

- Kraig Noble gave a brief summary of the use of the proposed annexed acreage with a
  possible housing project. John Bergman responded to the City's proposed use of land
  (housing project) west of St. Marys River Road by asking if the Recycle Center should
  be located where it is.
- 2) Electrical upgrade needs and who can provide the services at the Recycle Center were discussed. The City of St. Marys offer to present a cost proposal to extend the three phase service to the Recycle Center. Craig Moeller asked what the cost would be from Midwest Electric to install the three phase electrical service and Midwest Electric offered to submit a cost proposal for three phase service. A time frame to complete the three phase service will be presented the Commissioners by the City of St. Marys and Midwest Electric, Inc. Matt Berry also indicated that if the Recycle Center is not annexed that Midwest Electric would oppose the City of St. Marys' three phase service legally.
- 3) The City discussed their long term plans for use of the land adjacent to the landfill site and the cleanup of the canal. It was discussed that Kraig Noble has been in contact with ODNR about the canal. The City wants to annex up to Glynwood Road. The City wants to clean up the canal at a cost of approximately one million dollars. The City also invited the County and Noble Township to share in the cost of the clean-up of the canal. Grant Shaner stated that none of the constituents he has spoken to are in favor of this proposed annexation.
- 4) The discussion then focused on the requirement in the purchase agreement for annexation at a future date. The Board reminded the City representatives that the annexation provision was a last minute inclusion during the 2017 meeting. This annexation provision was made after the agreed to terms of the sale price and the acreage was determined. The current Board is reluctant to sign an agreement binding future Commissioners to an agreement. Kraig Noble stated the City would have to take the county to court if the provision was included and not followed by future boards because of a change of circumstances. The County Administrator asked if a compromise could be reached if annexation of the property that the City of St. Marys owns does not take place in two years that the requirement of annexation to be removed from the purchase agreement. The City Law Director was not interested in this suggestion.

He also discussed the potential generation fee change with a new business coming to Wapakoneta. He discussed sending out a survey of recycling for the Annual District Report.
