- 10 - Velcro Flap Single Smoke Canister \$ 600.00;
- 10 - Point Blank 8.5 x 4.5 vertical medical pouch w/zipper closure \$ 420.00; and,
- 10 - Zipper small misc. / utility pouch tuck strap w/molle


