WHEREAS, Scott Cisco, Auglaize County Solid Waste/Recycle Coordinator, recommended to the Board of County Commissioners the employment of a recycling laborer/truck driver for the current vacancy in the department; and,

WHEREAS, the Board solicited resumes for the position, receiving three (3) resumes; and,

WHEREAS, three candidates were interviewed for the position by the Board of County Commissioners, Solid Waste/Recycle Coordinator Scott Cisco and County Administrator Erica Preston; and,

WHEREAS, after the interviews and consideration of other candidates, Mr. Cisco recommended to the Board that the appointment for the recycling laborer be made to Tyler Varno.

THEREFORE, BE IT RESOLVED that the Board of Commissioners, Auglaize County, Ohio does hereby appoint Tyler Varno to the position of Recycling Laborer for the Auglaize County Solid Waste/Recycle District, appointment contingent upon a successful completion of his background check; and,

BE IT FURTHER RESOLVED that Mr. Varno rate of pay to be established at \$15.00 per hour with a potential increase of \$0.50 cents following the successful completion of the 180 day probationary period. Mr. Varno shall obtain his A CDL license and forklift license during the probationary period.
