**IN THE MATTER OF DECLARING THE WEEK OF MAY 10 – 16, 2020 AS NATIONAL POLICE WEEK IN AUGLAIZE COUNTY.**

The Board of County Commissioners of Auglaize County, Ohio met in regular session on the 12th day of May, 2020.

Commissioner Regula moved the adoption of the following:

**RESOLUTION**

**WHEREAS** in 1962, President John F. Kennedy and congress signed a proclamation which designated May 15th as Peace Officers Memorial Day and the week that it falls is known as “National Police Week”; and,

**WHEREAS** there are more than 900,000 law enforcement officers serving in communities across the United States, including the dedicated members of the Auglaize County Sheriff’s Office and local police departments in Auglaize County; and,

**WHEREAS** the members of our law enforcement agency play a significant role in safe guarding our community; and,

**WHEREAS** it is important for all residents to know and understand the duties, responsibilities, hazards and sacrifices of our law enforcement agencies. It is also vital that the members of our law enforcement agencies recognize their duty to serve the people and our community by shielding life and property by protecting the citizens of Auglaize County against violence and disorder; and,

**WHEREAS**, since the first recorded death in 1791, more than 20,000 law enforcement officers in the United States have made the ultimate sacrifice and have been killed in the line of duty.

**THEREFORE BE IT RESOLVED** that the Board of County Commissioners of Auglaize County, Ohio does hereby declare May 15<sup>th</sup> as Peace Officers Memorial Day and further declares that the week of May 10 - 16, 2020 is designated as “National Police Week”, and all residents of the Auglaize County are invited to salute the service of our law enforcement officers in our community and in the communities across the nation.
