CRITICAL INFRASTRUCTURE (CI) PROGRAM.**

The Board of County Commissioners of Auglaize County, Ohio met in regular session on the 12th day of May, 2026.

Commissioner Bambauer moved the adoption of the following:

**RESOLUTION**

**WHEREAS**, Auglaize County is applying for approximately \$1,000,000 to fund County-wide Community Housing Impact & Preservation (CHIP) Program activities for PY2026. Private Owner Rehabilitation \$580,000 (HOME); Owner Home/Building Repair \$300,000 (CDBG); Fair Housing \$6,000 (CDBG); and General Administration \$114,000 (\$56,000 CDBG and \$58,000 HOME). The CHIP activities satisfy the LMI National Objective. HOME Housing Program Income is also being committed to CHIP activities; and,

**WHEREAS**, on behalf of the Village of Waynesfield, the County plans to apply and proposes to use CI funds in the Village of Waynesfield as follows: East Side Storm Sewer Improvements: approx. \$470,000 Sewer Improvement (CDBG); and General Administration: approx.. \$30,000 (CDBG). CI activities satisfy the LMI National Objective. The County is applying for a total of \$500,000 to fund these activities. Village of Waynesfield local funds are also being committed to CI activities; and,

**WHEREAS**, on March 9, 2026, the Board of County Commissioners held the first public hearing for the CDBG/HOME programs; and,

**WHEREAS**, it is now necessary to set a date and time to hold a second public hearing for the PY2026 CHIP and PY2026 CI activities.
