
NOW THEREFORE, in consideration of the mutual agreements contained herein, the parties agree as follows:

IN THE MATTER OF FIXING DATE AND TIME FOR PUBLIC HEARING FOR THE ACCEPTANCE OF THE
"PRAIRIE CREEK BRANCH #2 DITCH PROJECT" INTO THE COUNTY'S PERMANENT DITCH
MAINTENANCE PROGRAM.

The Board of County Commissioners of Auglaize County, Ohio met in regular session on the 31st day of May, 2012.

Commissioner Bergman moved the adoption of the following:

RESOLUTION

WHEREAS, on May 22, 2012, County Engineer Doug Reinhart met with the Board of County Commissioners, reviewing plans and completed construction on Prairie Creek #2 Ditch project; and,

WHEREAS, County Engineer Reinhart presented the following correspondence to the Board:

Section 6131.63 of the Ohio Revised Code allows for landowners to reconstruct drainage ditches at their own expense, referred to as a "Group Projects", and the request for permanent maintenance through Section 6137 of the Ohio Revised Code.

In Section 30 of Logan Township, just west of the Easley Road and north of National Road, the joint effort of landowners Hugh Core and Ron Schwartz hired a contractor to reconstruct a 1200 foot section of an open ditch to provide an adequate outlet for a 455 Acre watershed. The reconstructed open ditch drains into the Prairie Creek channel which is currently on permanent maintenance.

The Auglaize Soil and Water Conservation office provided technical assistance to the landowners by providing their guidance and expertise to help manage the reconstruction of the open ditch, and have provided watershed and landowner information to our office so that an assessment schedule could be formulated.

The construction has been completed and the landowners have approached my office to place the reconstructed open ditch under County maintenance as outlined in Section 6137 of the Ohio Revised Code. I am requesting that the Board establish a date and time for a "maintenance hearing" where all of the affected landowners in the watershed will be legally notified of that hearing, and that the proposed assessment base for future maintenance collections be presented. At the time of this hearing, it will then be the decision of the Board of County Commissioners to determine whether or not this reconstructed open ditch will be accepted for permanent maintenance.

My office will send out the legal notices and a cover letter explaining the reasons for the notification, and an explanation of Section 6137 of the Ohio Revised Code. I would like to conduct this legal hearing in June before the farming community gets busy taking wheat crop off of their land. This project, should it be accepted, shall be named the Prairie Creek Branch #2.

THEREFORE BE IT RESOLVED, the Board of County Commissioners, of Auglaize County, Ohio does hereby set July 10, 2012 at 9:00 a.m. in the office of said Commissioners for the Maintenance Hearing on the Prairie Creek Branch #2 Ditch Project.
