Beth Miller reported the following: A new copier will be needed next year and in accordance with OSU policy it shall be leased and that will be an additional \$2,000.00 annual cost. She did not know the rotation cycle of the machine. The goat weigh-in took place last Saturday at the fairgrounds. She is working on preparing for the upcoming fair. They are training 27 new 4-H volunteers, 500 plus individuals are taking the Quality Assurance program, helped Putnam County with the Real Money Real World program, working with 4-H camp counselors and that the new pool at Camp Palmer will be dedicated soon.
 - Barb Hennard gave an update on the progress of the Grand Lake Challenge, working on the SNAP-ED program and has given several SafeServ programs.
 - Jeff Stachler reported that he is introducing himself to more individuals in the county, responded to a fly nuisance complaint, attended the cover crop meeting in St. Marys Twp at which there were 50 attendees and is working with Wright State University. He has contacted most of the Ag retailers in the county.
 - Lori Now reported that she has a program presence in every school in Auglaize County, which are 43 classrooms with 1052 students. She has butterfly kits in 31 classrooms, 23 chick hatching kits and 18 plant observation kits.

The Commissioners have already received two letters of interest to serve and will set up meetings with the applicants.
