 - NWGS renewal rates have been increased modestly for the VSP plan.
 - Chiller 1 for the Administration Building should be repaired or replaced before the next cooling season.
 - Our request for assistance for grant dollars through the Ohio Consortium of Crime Science has been assigned to a researcher at Bowling Green University. Administrator Preston will follow up with the researcher.
 - She is reviewing a question on the Opt Out/Opt Down provision for health care.
 - Miami County representatives will be here to answer questions on commercial permitting services for the county.
