- 7:30 a.m. Commissioner Bergman attended the NB/NK Rotary meeting this morning.
- 8:00 a.m. Commissioner Spencer moved to approve the resolutions. Commissioner Regula seconded the motion. The resolutions were then distributed for each Commissioner's vote and execution.
- 8:05 a.m. The Commissioners received and signed the check register as presented by the County Auditor's Office.
- 8:33 a.m. Clerk Leffel read the minutes of the November 17th, 2016 meeting. The minutes were approved as read.
- 8:40 a.m. Clerk Leffel reported the following:
 - Stated a letter has been received from the SWCD asking the Board to adopt the rules and regulations of sections 1515.28 to 1515.29 inclusive of the Ohio Revised Code concerning the Ritter #2 Ditch Project. The Board shall, within sixty days, approve or disapprove construction of the Ritter #2 Ditch Project.
 - Stated appointments have been scheduled for each Commissioner to speak with the NWGS representatives for December 8, 2016 on all supplemental insurance plans.
 - Reviewed the office calendar for the next several weeks.
- 8:54 a.m. County Administrator Preston conveyed the following:
 - Stated that a change order for the fabricated fascia has been received from Advanced Roofing Services for the Gutter & Downspout Project in the amount of \$6,852.00. The Board gave a verbal approval to proceed with the change order and instructed the Clerk to prepare a resolution.
 - Stated that the paperwork has been reviewed by her and County Prosecutor concerning the overpayment of a conveyance fee.
 - FAA call held on November 18th was productive but suggested that the Board schedule a call with Delta Airport Consultants to discuss further details of the county's airport improvement plan.
 - Spoke with Joe Lenhart concerning the contaminated soil for underground storage tank and how that was handled several years ago. During the staff meeting correspondence

- was received regarding the soil tests and there is no contamination showing on any samples collected.
- The Sheriff's Office has requested to use the county woods to do some canine training tomorrow evening. The Board approved their request.
- Had a conversation with Clerk of Courts concerning advertising expense and the use of the Treasurer's Dretac funds to pay for the advertising on foreclosures.
- Stated that Luke Garner has been scheduled to meet with the Board to discuss copiers for the county.
- Scott Cisco has stated that he has information concerning a used baler. This will be reviewed with Scott at his next monthly meeting.
- 9:00 a.m. County Coroner Dr. Tom Freytag presented the budget request for the next year.
- 9:15 a.m. Commissioner Bergman arrived at the office. He also stated that he attended the OSU Extension Advisory meeting last night.
- 9:30 a.m. Judge Mark Spees presented the budget request under his authority and Sally Imondi presented the budget request for youth services to the Board and County Administrator.
- 10:00 a.m. The budget hearing for the DD Board was held. In attendance were Todd Busse and Renee Place, County Administrator, Commissioners and WDN reporter Laura Germann.
- 10:30 a.m. County Recorder Chris Lambert met with the Board and County Administrator to present the budget request for operations in her office.
