The Board of County Commissioners convened in regular session at 8:00 a.m. on Tuesday, November 29, 2016 in the Commissioners' Chambers with the following members present: Don Regula, John N. Bergman and Douglas A. Spencer. The meeting of the Board was called to order by President Regula.

- 8:00 a.m. Commissioner Bergman moved to approve the resolutions. Commissioner Spencer seconded the motion. The resolutions were then distributed for each Commissioner's vote and execution.
- 8:35 a.m. Clerk Leffel read the minutes of the November 22nd, 2016 meeting. The minutes were approved with some clarification.
- 8:40 a.m. Clerk Leffel reported the following:
  - Asked if the newly elected officials are interested in a group oath of office with Judge Herman. The Clerk will get tentative dates from Grace Copeland.
  - Esther provided information on replacing or leasing the current postage machine being used in the Courthouse.
- 8:50 a.m. County Administrator Preston conveyed the following:
  - Erica met with the Public Defender and discussed the reimbursement from the state for assigned counsel expenses.
  - She noted that the 911 funds coming into the Sheriff's Office is declining. This
    historically paid three Dispatchers' salaries.
  - She met with the County Auditor on a reimbursement request of overpayment on conveyance fees.
- 9:00 a.m. Public Defender Gerald Siesel and Mandy Crowell met with the Commissioners and County Administrator to discuss the budget request for the office. He asked for increase in the indigent/assigned council line item to be more in line with adjacent counties.
- 9:30 a.m. Board of Elections Director Michele Wilcox and Board of Elections Board members Diana Dulebohn and Fran Engle met to discuss the budget for next year. The request is less than last year since the new voting equipment was purchased previously. The Wapakoneta Daily News reporter Laura Germann and The Daily Standard reporter Jared Mauch were also present.
- 10:00 a.m. Beth Miller from OSU extension presented their request for 2017. She explained that the State increased the salary of the 1<sup>st</sup> educator after the initial request in May.

- 1:00 p.m. Sheriff Allen Solomon, Chief Deputy Mike Eberle, Mary Vorhees, Lisa Wright and Mike Vorhees met with the Board and County Administrator to discuss the department's budget request. Some items discussed were the replacement of the DARE vehicle. It is starting to need repairs. There was request to increase the hours of the part-time kitchen worker but keep the hours below 30 hours so that this employee would be eligible for insurance at the part-time rate. Also discussed was the amount of 911 funding. The Daily Standard reporter Jared Mauch and The Wapakoneta Daily News reporter Laura Germann were also present.
- 2:00 p.m. Law Library Board Member Kraig Noble and Law Librarian Lucy Merges met to discuss the Law Library budget for next year.
- 3:00 p.m. The Board held a budget meeting with the various communities to discuss proposed funding levels. Present for the meeting were: County Administrator Erica Preston, Village of Minster Administrator Don Harrod, Village of New Bremen Economic development Director Angela Hamberg, Village of New Knoxville Administrator Rex Katterheinrich, City of Wapakoneta Mayor Tom Stinebaugh, City of Saint Marys Mayor Patrick McGowan, WAEDC Director Greg Myers, WAEDC Board member Michael Burton and City of Saint Marys Law Director Kraig Noble. There was a request from some of the WAEDC members to fund a grant program based on the population of the school districts. The Board was not in favor of this request. Rex Katterheinrich also proposed a matching funds program from each community to match the county's contribution.
- 4:00 p.m. The staff meeting was continued with Erica reported that attorney Ethan Welch has indicated the Auglaize Industries Board has signed the lease agreement for the use of the current Industries Building. The Board will do a pre inspection of the building before the lease begins.
