To All Interested Persons, Agencies, and Groups:

On or about, but not before, **November 16, 2016** the Auglaize County Board of Commissioners will submit a request to the State of Ohio for the release of Federal funds under Section 104 (g) of Title I of the Housing and Community Development Act of 1974, as amended; Section 288 of Title II of the Cranston Gonzales National Affordable Housing Act (NAHA), as amended; and/or Title IV of the Stewart B. McKinney Homeless Assistance Act, as amended; to be used for the following project(s):

**Auglaize County PY2016 Community Development Block Grant (CDBG) Allocation Program**

Auglaize County will use its Allocation funds to assist two communities with Public Facilities projects: City of Wapakoneta Maple Street and Moulton Township Public Rehabilitation.

#1-1 – City of Wapakoneta Maple Street Flood & Drainage Facilities. CDBG Cost: \$18,400. Installation of six (6) catch basins and two (2) storm manholes along Maple Street, between East Benton Street and the railroad tracks. Phase 1 of Multi-year project. Total Activity Cost: \$18,400.

#1-2 – City of Wapakoneta Maple Street Sidewalk Improvements. CDBG Cost: \$59,000. Replace and repair approximately 1,850 LF of sidewalks and approximately 363 LF of driveway approaches on both sides of Maple Street, between East Benton Street and the railroad tracks. Phase 1 of Multi-year project. Total Activity Cost: \$59,000. Total Project Cost for Phase 1: \$77,400.

Subsequent phases of the Wapakoneta Maple Street project are anticipated to be funded with CDBG and may include Sewer Facility Improvements, Water Facility Improvements, and Street Improvements.

#3-1 – Moulton Township Public Rehabilitation: Neighborhood Facility/Community Center. CDBG Cost: \$13,000. Replacement of existing entry door at Moulton Township Hall with ADA accessible entry door, including push button opener and all electric. Single year project. Total Activity Cost: \$13,000.

PY2016 CDBG Allocation Program also includes funding for General Administration and Fair Housing. Estimated Total Cost of all Program Activities: \$113,000± per funding cycle.

The Auglaize County Board of Commissioners has prepared an Environmental Review Record (ERR) for each of the projects listed above. The ERR documents the environmental review of the project(s). The ERR is on file and available for the public's examination and copying, upon request, between the hours of 8:30 a.m. and 4:30 p.m., Monday through Friday (except holidays) at the above address.

The Auglaize County Board of Commissioners plans to undertake the project(s) described above with the Federal funds cited above. Any interested person, agency, or group wishing to comment on the project(s) may submit written comments for consideration to the Auglaize County Board of Commissioners at the above listed address prior to **November 16, 2016**.

The Auglaize County Board of Commissioners certifies to the State of Ohio that Don Regula, in his capacity as President, Board of County Commissioners, consents to accept the jurisdiction of Federal courts if an action is brought to enforce responsibilities in relation to the environmental review process and that these responsibilities have been satisfied.

The legal effect of the certification is that upon its approval, the Auglaize County Board of Commissioners may use the Federal funds, and the State of Ohio will have satisfied its responsibilities under the National Environmental Policy Act of 1969, as amended.

The State of Ohio will accept an objection to its approval of the release of funds and acceptance of the certification only if it is on one of the following grounds: (a) the certification was not, in fact, executed by the responsible entity's Certifying Officer; (b) the responsible entity has failed to make one of the two findings pursuant to Section 58.40 or to make the written determination required by section 58.35, 58.47, or 58.53 for the project, as applicable; (c) the responsible entity has omitted one or more of the steps set forth at subpart E of 24 CFR Part 58 for the preparation, publication, and completion of an Environmental Assessment; (d) the responsible entity has omitted one or more of the steps set forth at subparts F and G of 24 CFR Part 58 for the conduct, preparation, publication, and completion of an Environmental Impact Statement; (e) the recipient has committed funds or incurred costs not authorized by 24 CFR Part 58 before release of funds and approval of the environmental certification by the State; or (f) another federal agency, acting pursuant to 40 CFR Part 1504, has submitted a written finding that the project is unsatisfactory from the standpoint of environmental quality.

Written objections must meet the conditions and procedures set forth in subpart H of 24 CFR Part 58, and be addressed to: State of Ohio Development Services Agency; Office of Community Development; Environmental Officer; P. O. Box 1001; Columbus, Ohio 43216-1001.

Objections to the Release of Funds on bases other than those stated above will not be considered by the State of Ohio. No objections received after **December 6, 2016** (which is 15 days after it is anticipated that the State will receive a request for release of funds) will be considered by the State of Ohio.
