- 8:40 a.m. Clerk Leffel reported the following:
 - She has spoken with the Mayor of Buckland and the Village Administrator of Waynesfield about having Miami County providing plan review and inspections services in Auglaize County. They will respond back to the Clerk after discussion with their village councils.
 - Reviewed the office calendar for the next several weeks.
- 8:50 a.m. County Administrator Preston conveyed the following:
 - She has had discussion with several County Administrators on possible reimbursement
 of overpayment of conveyance fees since the County Auditor does not have authority to
 refund an overpayment of a conveyance fee. The Board authorized Administrator
 Preston to discuss her findings with the County Prosecutor so that he could move
 forward with resolving the issue with National Church Registry on a recent overpayment
 of the conveyance fee to the general revenue fund.
 - She and the Clerk of the Board are working on a resolution dealing with Veterans ID cards.
 - A telephone conference will be held with the FAA on Friday November 18, 2016.
 - An adjoining landowner to the airport has a drainage issue.
 - The lighting for the parking lot east of the Courthouse appears to be insufficient. The
 City of Wapakoneta will provide space on their light poles to provide lighting for the
 parking lot. The city will install the lights and maintain them for a monthly fee of \$14.50
 per month per light. Two lights will initially be installed with one additional light if
 deemed necessary by the County.
 - She forwarded a complaint to the ACDJFS Director.
 - She is working with NWGS on the active/passive enrollment for flex spending and supplemental benefits. She informed the board that the critical illness plan will need to be changed to be compatible with a High Deductible Health Plan.
 - She discussed various options discussed at the wellness meeting vesterday.
 - Discussed maintenance items at the ALEC.
