The Board of County Commissioners of Auglaize County, Ohio met in regular session on the 17th day of October, 2024.

Commissioner bergmen moved the adoption of the following:

RESOLUTION

- WHEREAS, on April 13, 2013 in Resolution #13-176 the Board of Auglaize County Commissioners established the regulations for the use of the Auglaize County Courthouse and Grounds and Application/Permit for the use of the property and grounds; and,
- WHEREAS, the Board has reviewed and amended these regulations and a use application/permit which it feels are reasonable and necessary for the use of the newly renovated County Courthouse and Grounds.
- THEREFORE, BE IT RESOLVED that the Board of County Commissioners, Auglaize County, Ohio does hereby amend the attached "Regulations for the Use of the Auglaize County Courthouse and Grounds" and the "Application/Permit for Use of the Auglaize County Courthouse Property and Grounds", making said regulations effective as of this date, October 17, 2024; and,

BE IT FURTHER RESOLVED that by attaching said Regulations, same thus becomes a part of this Resolution.

REGULATIONS FOR THE USE OF THE AUGLAIZE COUNTY COURTHOUSE AND GROUNDS

NOTE: ANY PERSON OR ORGANIZATION REQUESTING THE USE OF THE AUGLAIZE COUNTY COURTHOUSE AND GROUNDS SHALL READ THESE REGULATIONS AND SHALL AGREE TO THE TERMS AND CONDITIONS CONTAINED HEREIN.

- 1. The user organization shall not permit any action inconsistent with or in violation of local, state, or federal laws.
- 2. The user organization shall maintain the grounds and facilities in a reasonable manner during the term of this permit, keeping them clean, sanitary, and free of debris. After termination of this permit, the areas used shall be restored to the same conditions as prior to the event/tour.
- 3. Areas available for public use are:
 - a. Exterior stairs and lawn of the Courthouse
 - b. Inside the Courthouse on the main floor lobby
- 4. For use of the exterior stairs and lawn of the Courthouse, security or other law enforcement may not be required.
- 5. Custodial staffing shall be required for all events held at the Courthouse. The user organization will be charged for any and all labor, materials, and equipment associated with the event.
- 6. For inside the Courthouse, Security or other law enforcement personnel are required to ensure that the Courthouse remains a secure facility, the user organization will be charged for any and all labor, materials, and equipment associated with the event/tour.
- 7. No equipment, machine, or motor vehicle is permitted on the Auglaize County grounds without prior approval of the Board of County Commissioners.
- 8. The use of stickers or labels, cellophane pressure sensitive tape, screws, nails, sticks, poles, or any other mounting technique for displaying signs, banners or flags which adversely affects the structural of decorative condition of the Auglaize County Courthouse and grounds is prohibited.
- 9. Electricity may be provided by Auglaize County if requested in the application. There is a ten dollar (\$10.00) charge for each electrical hook-up or connection (no extension cords will be provided). Security staff cost will be a set rate per hour and custodial staff will be a set rate per hour.
- 10. Use of the Auglaize County Courthouse and grounds shall only be done in a manner not to interfere or compete with normal Auglaize County business operations.
- 11. Use of sound equipment shall be in compliance with local noise ordinances and used in a manner not to interfere with Auglaize County government business proceedings or other activities being conducted on Auglaize County property. The county will not provide any sound equipment.
- 12. No food, beverages or merchandise shall be sold or dispensed on Auglaize County property without express written consent of the Board of County Commissioners. No transient vendors are permitted to use the Auglaize County facilities.

- 13. The user organization shall indemnify and hold harmless the County of Auglaize and the Board of Auglaize County Commissioners and its employees agents and assigns against any and all claims, demands, actions or accused of actions, together with all losses, costs or related expenses asserted by any person or persons for bodily injury, death or property damages resulting from or arising out of this permitted use of the Auglaize County Courthouse and grounds.
- 14. The user organization will be assessed a deposit to cover anticipated expenses that may be incurred by the County should the Board of County Commissioners approve the Applicant's request. The deposit must be in the form of cash, check or bond and must be paid at least two (2) weeks prior to the scheduled event day. The amount of the deposit will be set by the Board of County Commissioners and will be based on anticipated expenses that may be incurred by the County as a result of granting this request.
 - a. The request will be considered **ONLY AFTER** all necessary paperwork is completed and a deposit has been received.
- 15. At the discretion and request of the Board of County Commissioners, the applicant shall provide evidence of insurance and name Auglaize County as additional insured.
