RESOLUTION

WHEREAS, a Service Agreement for Inmate Banking & Commissary Services from Stellar Services, LLC was received by Sheriff Michael Vorhees; and,

WHEREAS, said agreement provides the terms under which Stellar Services, LLC, will provide such services; and

WHEREAS, the term of the agreement shall begin on the effective date 7/25/2025 through 7/25/2026 for a period of one (1) year. The term of this service agreement will automatically renew under same terms and conditions consecutively for three (3) year periods, if notice of termination is not received ninety (90) days prior to completed initial minimal term or any renewal term; and,

WHEREAS, Sheriff Vorhees has recommended to the Board that the agreement be entered into with Stellar Services, LLC.

THEREFORE, BE IT RESOLVED that the Board of County Commissioners of Auglaize County, Ohio, does hereby approve the recommendation of Sheriff Michael Vorhees for the Service Agreement for Inmate Banking & Commissary Services, authorizing the execution of the agreement, as presented, with Stellar Services, LLC; and,
