In 1988, Congress expanded the week to a month and changed the name to "National Disability Employment Awareness Month"; and,

WHEREAS, the Auglaize County Board of Developmental Disabilities (Auglaize DD) has chosen "Today's Workforce: Powered by Inclusion" as this year's theme for NDEAM in celebration of individuals with disabilities and their contributions and achievements to the American workforce; and,
