

The Receiver has reviewed Proof of Claim Number 47 filed by 617885 Ontario Ltd. The Proof of Claim includes Exhibit A, which is a list of Notes and an accrued interest table. It also includes Exhibit B, which is a list of Exhibits 1 – 46, some of which are Subordinated Promissory Notes. The Receiver hereby recommends that the Proof of Claim be ALLOWED, in part.

Exhibit A lists seventeen Notes with dates beginning October 5, 2017 and ending May 23, 2018, and, where applicable, calculations of interest through maturity dates and interest at default rates, all through the date of October 29, 2018. Fifteen of the Notes are in United States Dollars and other two are in Canadian Dollars. The Receiver recommends approval of all but one of the Notes, with interest as calculated through October 29, 2018, as claimed.

The single omitted Note is the Note dated January 30, 2018 in the amount of \$2,000,000 Canadian Dollars, found at the last line of Exhibit A. The Receiver takes no position regarding that Note.


