The Board of County Commissioners convened in regular session at 8:00 a.m. on Tuesday, September 15, 2026 in the Commissioners' Chambers with the following members present: John N. Bergman, Douglas A. Spencer and David Bambauer. The meeting of the Board was called to order by President Bergman.

- 9:23 a.m. Clerk Bobbi Donovan presented the minutes of the September 10, 2026 meeting.

- 9:31 a.m. County Administrator Preston presented the following:
 - The Board chose to continue the .5 mil voluntary reduction on property tax.

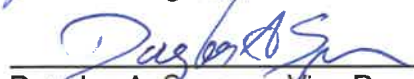
#26-396 Matter of amending the Annual Appropriation due to moneys certified and not appropriated.
