 Commissioner Bergman seconded the motion. The resolutions were then distributed for each Commissioner's vote and execution.
- 8:05 a.m. The Commissioners received and signed the check register as presented by the County Auditor's Office.
- 8:30 a.m. Clerk Leffel read the minutes of the September 27, 2016 meeting. The minutes were approved with some clarification.
- 8:35 a.m. Clerk Leffel reported the following:
 - Informed the Board that foreclosure on a CHIP property is proceeding.
 - · Asked for agenda items for the next elected officials and department heads meeting.
 - Received grant dollars for the Auglaize Acres wheelchair accessible van.
- 8:40 a.m. Administrator Preston conveyed the following:
 - Talked to Phyllis Nielsen and asked her to review the health care letter to be circulated to the employees.
 - Received correspondence from person who was charged with a moving violation in Auglaize County by the State Highway Patrol. The Board instructed her to inform this party again that the Commissioners have no jurisdiction in this matter.
- 8:45 a.m. Commissioner Spencer stated to have Rick Bice schedule a generator test for the Law Enforcement Center.
- 8:50 a.m. Commissioner Bergman asked that a check made out to Edge Factor be held back from the printed check register as there was insufficient information for the Board and asked Administrator Preston why she authorized payment. He reminded the Board that they were asked to attend a meeting on August 22, 2016 at the Mercer ESC about the topic and that it was asked if a meeting on the topic could be held in Auglaize County as no one could make the Mercer County meeting. No meeting was held in Auglaize County.

Administrator Preston indicated that she had originally received a request from the Auglaize County ESC to consider funding EduFactor as a workforce development tool for Auglaize and Hardin County districts served by the Auglaize County ESC at a 100% level. After having additional discussions with ESC Superintendent Shawn Brown and attending the August 22nd meeting in Mercer County, it became clear that the level of funding requested was scaled back to only a portion of the cost for Auglaize County districts as was in line with her original understanding based on conversations with Auglaize and Mercer County

Economic Development. Administrator Preston did not schedule a follow-up meeting prior to authorizing the payment. When asked if she communicated the scaled back request to the Board she indicated that she believed she had, but could check her notes to confirm. Administrator Preston acknowledged the reason for discussion on the authorization of the payment.

Commissioner Spencer indicated that the check register had three signatures which validate the check register. Commissioner Bergman disagreed and indicated he signed the check register with notification that he had asked the county auditor's office for the actual invoice and check to be given to him for review. Commissioner Regula agreed that two signatures validate the check register. Commissioner Bergman returned the check to the Auditor's office.

Commissioner Spencer asked if a lower spending limit is in order and should it be \$1,000.00 dollars. Commissioner Bergman agreed. The Board seems to be in agreement, however, no resolution has been passed.
