

**IN THE MATTER OF AUTHORIZING A FINANCIAL COMMITMENT TO SUPPORT THE AUGLAIZE MERCER BUSINESS EDUCATION ALLIANCE (AMBE) FOR WORKFORCE DEVELOPMENT.**

The Board of County Commissioners of Auglaize County, Ohio met in regular session on the 3rd day of September, 2019.

Commissioner Spencer moved the adoption of the following:

**RESOLUTION**

**WHEREAS**, the Auglaize Mercer Business Education Alliance (AMBE) includes a network of local business who are working diligently to capture the attention of students, parents and school personnel to create a sustainable, viable future for our local communities. AMBE has requested from the Board of County Commissioners, Auglaize County, Ohio to make a financial commitment of \$25,000.00 for a six month period and future funding to be determine after the long term plan has been presented; and,

**WHEREAS**, with this funding, Auglaize County could expect the following:

- Continue to sustain the work and programs currently in place by AMBE.
- AMBE would become the catalyst for the Auglaize County business community. AMBE (Shelly Busse) would represent workforce development in Auglaize County and engage the businesses in Auglaize County.
- AMBE would continue to be the bridge between the schools and the business community. We would utilize career assessment software to develop career pathways. This tool can be customized with local data to provide students visibility to careers in Auglaize and Mercer Counties.
- Initiate the coordination of developing the road map. We need to answer the question, "What is the long term plan for workforce development in Auglaize County?"

**THEREFORE BE IT RESOLVED**, that the Board of County Commissioners, Auglaize County, Ohio does hereby authorize the financial commitment in the amount of \$25,000.00 shall be made to the Auglaize Mercer Business Education Alliance; and,

**BE IT FURTHER RESOLVED** that said Board authorizes the Clerk of the Board to proceed with the necessary steps to cause the payment of \$25,000.00, made payable to Auglaize Mercer Business Education Alliance.

The main goal of the program is to move participants to self-sufficiency through employment. The Auglaize County JFS and Auglaize County Recycling Center agree that as a condition of this agreement, there shall be no discrimination against any participant on the basis of race, color, national origin, sex, or handicap or any other factor as specified by federal and state laws regarding discrimination; and,

**WHEREAS**, this agreement shall become effective on September 1, 2019 and will expire on August 31, 2021.
