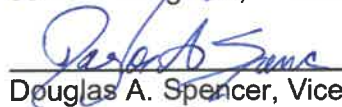
#26-380 Matter of authorizing the County Auditor to draw warrants for Then and Now Certificate payments.

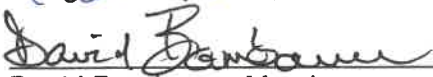
#26-381 Matter of amending the Annual Appropriation due to moneys certified and not appropriated.

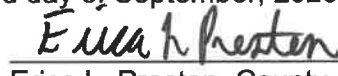
12:30 p.m. With no further business to bring before the Board President Bergman adjourned the meeting for the day.

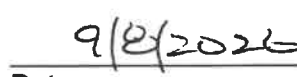
