Those in attendance were Choice One Engineering representative Ryan Lefeld, Mayor of Buckland Tim Detty and three bidders. - 10:30 a.m. The Auglaize County Commissioners met via phone with the Logan County Commissioners to certify assessments for the Metz and Swartz Joint ditches. Also in attendance were Auglaize County Engineer Andrew Baumer and Ross Wuebker via telephone. The Joint Board approved resolution #22-388.
- 11:00 a.m. The Commissioners, County Administrator and IT Manager met with Board of Elections Director Michelle Wilcox, Assistant Director Mandy Frank, Ohio Secretary of State Representatives Spencer Wood and Jillian Bruner, Auglaize Board of Elections members: Diana Dulebohn, Rodney Metz, Fran Engle and Bill Roth to discuss specific items that were included in the election security directives.
- 1:00 p.m. Sheriff Vorhees and Chief Deputy Peterson met with the Board and County Administrator to discuss the medical unit at the Law Enforcement Facility. The Sheriff presented his recommendation to the Board to move forward with a contract with Premier Health Care Services, also referred to as TeamHealth. The contract would cover nursing and physician services for the Law Enforcement Center. This recommendation comes following the formal RFQ process, the presentation by the top two responding companies (also the only two responding companies) and negotiations with TeamHealth. The Sheriff explained that his office would receive more hours of coverage at a rate per hour that is comparable or less than his current structure. He further explained that the level of services provided would include compliance and oversight from professionals in the medical field. The Sheriff and the Board discussed the consequences of moving towards contracting these services, with the most notable concerns being job abolishment and termination of existing contracts. The Sheriff explained that he has considered these items and still believes the transition to contracted services to be in the best interest of the County at this time. The Sheriff has discussed the potential for current personnel to be hired by TeamHealth but conceded that it would be a decision made by TeamHealth and beyond the control of the County. Following all discussions, the Board instructed the County Administrator to work with TeamHealth personnel to negotiate the terms of a contract in a form that could be presented to the Board for final review and consideration.
