- 8:35 a.m. The Board read the minutes of the September 3, 2015 meeting. The minutes were approved as read.
- 8:55 a.m. Administrator Preston conveyed the following:
 - Asked if the Commissioners are interested in changing the name of Infirmary Road as requested by Todd Wheeler. This was requested several years ago. The Board will send correspondence on its position concerning this matter and at this time have declined to take action on our own motion to change the name of Infirmary Road under ORC 5541.04.
 - Correspondence from a company called Tax Ease that purchases tax delinquent properties has been received. The Board is not interested in a contract at this time.
 - Inquired if the Commissioners are interested in one, two or three year contract with Worxtime for ACA Compliance process. The Board authorized the County Administrator to finalize the term of the contract based on feedback received from Arthur Gallagher.
 - Received a letter from the LEPC indicating the officers for the term being August 2015 through August 2017.
 - The specifications at the Law Enforcement Center for the pipe lining project will be going out soon
 - Discussed with Board about the timing of the lightning protection project for the Courthouse and the Board decided to move forward in 2016.
 - Erica is putting a list together of AG opinions relevant to the Commissioners' office and reviewed some of the more recent ones.
 - Spoke with Renee Place about BOCC maintenance personnel to be under contract for the snow plowing at the Group Home adjacent to Auglaize Acres for \$100 per occurrence and the Group Home to be billed on a monthly basis.
- 9:05 a.m. Extension staff met with the Board and County Administrator for the quarterly update. Beth Miller reported that the copier in their office has reached it useful life expectancy and it will be replaced with a leased unit as required by OSU extension. Camp Palmer attendance was good this year and the new pool was operational. She reviewed the operation of the completed Auglaize County Fair with Fair Manager Fred Piehl.

Beth Hennard presented highlights of the recent Grand Lake Health Challenge. She is teaching the Serve Safe food program again this year. She is working on a Choose it (proper food) and Use it (exercise) program.

Jeff Stachler reported that he is working with a corn grower to compare the results of 28% nitrogen application vs. manure application. He is also working with two

growers on opposite ends of the county to determine any limitation of growing soybeans. Shelby, Mercer and Auglaize Counties hosted a fertilizer certification training program. He will be hosting a farm transition meeting this fall. Speakers will be from the Extension Service and attorney Bob Moore from Columbus.
