

**All of our drop offs currently accept the following materials:**

Glass, Aluminum, Tin, Cardboard, Mixed Paper, #1 PETE Plastic, #2 Natural Plastic, #2 Color Plastic, #5 Plastic, Plastic Bags (in designated container). Please read all signage to ensure all items are placed in their appropriate containers. Placing large items on the ground is considered open dumping. If you have something you are unsure about, please call or text our office.

*Ohio Revised Code 3734.03 – Open burning or open dumping of solid wastes. No person shall dispose of solid wastes by open burning or open dumping. If done recklessly, the crime is an unclassified felony.*

*Ohio Revised Code 3734.99 - Penalty – Whoever recklessly open-burns or open-dumps solid waste is guilty of a felony and shall be fined at least \$10,000 but not more than \$25,000, or imprisoned for at least two years but not more than four years – or both.*

## Accepted Materials



All glass bottles and jars. All lids must be removed from the glass. We can recycle only container glass. NO ceramics, cooking glass, window glass or auto glass.

### Glass

Aluminum cans, tin and steel food cans. Aerosol cans that are empty are also accepted. Foil and pie pans are accepted.



We accept scrap steel, but we do not purchase it at this time.



### Cans/ Foil

Only accepted at 15502 St Marys River Rd, St Marys, Ohio



Please breakdown all boxes to use less space in transportation to processing center.

### Cardboard

This is the newspaper, slick ads, phone books, shredded paper, office paper, junk mail, paper board (Cereal type boxes), magazines, cartons, office paper, paper bags, and envelopes.



\*Please empty all paper out of all plastic bags, including shredded paper.

### PAINT

We accept latex and oil based paints. We charge \$1.00 per container up to one gallon, then each additional gallon is \$1.00. All paint aerosols are \$0.25 per container. Do NOT mix latex with oil based paints. If you have any empty dried out containers, we can accept those for free.

### CHEMICALS, HERBICIDES, CLEANERS, PESTICIDES, MOTOR OIL, BATTERIES, GASOLINE

We charge \$1.00 per pound for all items above. Car Batteries are free of charge. We do not dump out ANY materials due to the potential hazards.

### LIGHTBULBS (up to 8 feet)

We charge \$2.00 per bulb . Please do not break or crush bulbs before bringing them to our facility. If you have broken lightbulbs, they are charged \$3.00 per pound.

### MERCURY

We charge \$35.00 per pound. We will NOT remove the mercury to weigh it under any circumstances. There is a \$17.00 minimum charge.



### TIRES—MUST BE OFF THE RIM

We charge \$0.25 per pound.

### PAPER SHREDDING

We charge \$0.25 per pound.

## FAQ's

### Why are we mixing materials at my recycling drop off?

Our facility now has the ability to sort the tin, aluminum, and plastics with the assistance of equipment. This allows those specific materials to be mixed at the drop offs. Please do not put any plastic bags or larger items in the container because it causes these machines to shut down.

### What kinds of plastic bags can I recycle?

Plastic bag recycling can be any type of empty and clean plastic bag. Examples may be grocery bag, bread bag, bubble wrap, salt bags, cereal bags, produce bags, etc. Please remember plastic bags have their own designated container!

### Why do we have to make an appointment?

Our facility has over 10 million pounds of recyclables entering and exiting our facility throughout the year. There are several trucks, forklifts, skid loaders, and other equipment operating throughout the work day. For the safety and security of everyone, we have these appointments to ensure adequate staffing and to watch for these extra vehicles entering our working areas.

### Can you recycle Styrofoam and concrete?

Unfortunately, our facility is not able to recycle any construction or demolition debris. Please reach out to your local village or city for additional information. Styrofoam is recyclable, but because it is light weight, bulky, and difficult to clean due to its porous nature, it's a costly material to recycle at an efficient scale.
